The Adopt a School event is designed to help students in underserved communities receive school supplies and personal protective equipment. Minnis will select one school from one Pinellas County's "Five Failing Schools" and Mt. Zion Christian Academy, Inc. (K-5th grade) that is 90% African American in South St. Petersburg. Both schools are in low income areas. Minnis will work with school's guidance counselor and social workers to determine the needs of the students. We will ask the schools to send us list of supplies. Some of the items will include classroom supplies, masks for kids, and sanitizing supplies. We will create an Amazon wishlist of these supplies for attorneys and community to ship directly to schools. Our young lawyers will purchase supplies to hand deliver to the schools during the first week of school.
