HAWL YLD would like to do a community service event for Tampa Crossroads, specifically, their Rose Manor program. The Rose Manor program is a residential treatment program exclusively for women with problems such as substance abuse. The women reside in a beautiful landmark historic house in Tampa (more information here <https://tampacrossroads.com/rosemanor/>)

The Rose Manor program is putting together a therapy garden for the residents to grow veggies and be able to use as part of their treatment therapy. HAWL would like to assist in starting the therapy garden program by: 1) hosting an event to help the residents, alongside HAWL YLD members, to plant veggies and other plants and get the area set up, and 2) providing materials to assist with the gardening, such as gardening tools, gloves, watering cans, plant seeds, etc.

HAWL would also provide light refreshments and snacks for the Rose Manor for the planting/gardening event.

We plan to hold the event in early fall (I cannot fill out a date where it requests one below, as it only allows numbers 1-100 or something like that).

The funds would be used to purchase gardening materials needed, such as gardening tools, gloves, watering cans, plant seeds, soil, fertilizer, wood to create the garden bed or planters etc. or potentially a bench or other materials needed for the Rose Manor garden. We are still working out the specifics with Tampa Crossroads. We would also provide light refreshments and snacks for the Rose Manor for the planting/gardening event. We do not have a current breakdown of the specific amounts, but can provide it as the details become available. All additional costs beyond \$500 would be sponsored by HAWL directly.

This event will provide service and impact the local community and allows an opportunity for HAWL YLD members to interact and assist with an event that will have a long lasting impact on the Rose Manor. This would not be a pass through but would be providing materials for a long term therapy program and resource for the residents at the Rose Manor and will also provide refreshments during the event where HAWL members and the residents would get to interact.
