Description:**

The Osceola Bar seeks to host a curbside backpack drive in July 2021. It is pretty well known that the pandemic has had a major impact on our community and society as a whole, but our children have been negatively impacted on a variety of levels as well. With the push toward virtual schooling, there are children in need of school supplies (which they regularly use at school). This has taken a financial toll on parents, especially those who lost their jobs (and continue to do so) during this pandemic. There are always homeless or low income children in need of school supplies, and the pandemic has exacerbated the number of children in need.

The Osceola Bar wants to do what it can to bridge the gap. Hence, our curbside backpack drive.

The event will be hosted in the parking lot of Perez Lasure Law Firm, located at 517 W. Bryan Street, Kissimmee, Florida.

We will invite our members to donate school supplies for the event and join us at the event to stuff the backpacks with the supplies. Looking ahead, we hope that we would not have to be concerned about COVID-19 by July of 2020, but we are choosing to make the event social-distance compliant by allowing those members who prefer to remain socially distanced to drop their donated supplies curbside for another member to retrieve.

The event will be outdoor and any members that wish to participate in stuffing the backpacks may do so. We will rent tables and chairs, purchase light refreshments (appetizers and soft drinks/water), as well as dedicate a portion of the monies received from the grant to purchase school supplies.

At the end of the event, the Osceola Bar will donate the backs packs to a local community organization's annual backpack drive for children in need.
