JWLA has developed a new program this year entitled "Stepping into connections". This program will include a variety of events such as group walks, group dancing events, family friendly scavenger hunts, and more designed to promote activity/health and wellness and to also establish connections and build relationships between members of the legal community and their families.

We are kicked off the Stepping into Connection program this year with a walk on Saturday, September 4 at 10:00 am at Jacksonville Arboretum & Gardens . This event also served as a Mentoring opportunity and kid friendly event with an activity for kids while the adults walk and connect.

We hope to fill each activity with law students, seasoned attorneys, judges, young lawyers, and community members. One of the events this year will focus on enhancing the Duval County Courthouse lactation room. We will invite judges, attorneys, young lawyers and other members of JWLA and their children to join us for a day of arts and crafts and fundraising. The children will be provided craft materials to create artwork for the inside of the lactation room. Parents and other volunteers will be provided an opportunity to network and build connections while the children play. There will also be a call for donations for needed supplies/consumables for the lactation room.

How will the YLD funds be utilized?:	The money will be used to purchase arts and craft supplies, and some frames for the drawings by the children which will be displayed on the lactation room walls. We will also use the money to purchase snacks, juice and water for event participants. If there is any leftover money from the arts and crafts, and snacks, the money would be used to purchase supplies/consumables for the lactation room, such as diapers, diaper pail bags, wipes and other baby products, that we currently rely on donations to stock.
How does your event fit into the parameters of the Grant?:	This event fits into the parameters of the grant in many ways. It's focused on improving the lactation room at the courthouse, which is available to judiciary, attorneys and guests. The judiciary and their children are also invited to attend the event, and connect with other attorneys. There is a health and wellness component in that many of the stepping into connection events focus on health and wellness. Each of the stepping into connection walking events, features a member of the judiciary as the spotlighted guest.
