YLS will be partnering with the Palm Beach County Bar Association's Solo & Small Firm Committee for this event. Our event is tentatively scheduled to take place in person on May 14, 2022.

We'll begin our day meeting at Riverbend Park in Jupiter for a 2-hour kayaking guided tour with 2 people per kayak. After our tour, attendees will get in their car and take a 10 minute drive over to Taylor Farmhouse Café, a local restaurant with a beautiful outdoor space and healthy eating options, for a catered lunch. Attendees will have the options to kayak and eat, only kayak, or only eat.

We are also thinking of having a speaker such as a therapist or psychiatrist during the lunch to speak on the importance of mental health and destigmatizing such conversations in the legal profession.

We estimate that we will have 25 people from each group attend, 25 from YLS and 25 from the Solo & Small Firm Committee.
