Sometime during the spring of 2022, FAWL will be hosting a virtual 5k to benefit various charities across the state. We will ask local FAWL affiliates to register for the 5k, then self-report their times via a Google Doc. The affiliates with the most participants will be able to choose the charities that receive the funds, or in the alternative, FAWL will select a few charities then let participants vote on their race entry forms who should receive the proceeds. This event is COVID-proof, as it requires no meetings with anyone, can be done during a time window of likely 30 days, and gift bags will be mailed to the participants (or they can choose to opt out and donate the entire portion of their race entry cost.) The cost will be \$35 per person and will include a t-shirt and swag bag (bag pending additional sponsors). We will seek donations for prizes for the top runners in each category. The \$500 we are requesting will be to offset the cost of t-shirts, postage, and any other related expenses. Anyone throughout the state can participate, and with the time window being so generous, we should be able to get a lot of participants and raise a lot of money for the charities!
