It is critical that the 7th graders receive these books since the constitution is used throughout the school year in preparation for their end of year civics test. The 7th graders are advised to keep the books since they are also used during 8th grade. We plan to deliver approximately 1,600 pocket constitutions to students at all public and private middle schools in the county.

We will purchase the pocket constitutions from the Florida Bar in the early summer so that they will be shipped by the end of the summer and be available for teachers to pick up for their students before the start of the 2021-2022 school year.
