In honor of International Women's Day, the OCBA YLS plans to hold a Spring Halloween event, benefitting PACE Center for Girls ("PACE"). Members will be encouraged to dress as their favorite female icon to help raise funds and awareness for PACE. PACE is a non-profit organization that provides free year-round middle school and high school academics, case management, counseling and life skills development in a trauma-informed and gender-responsive environment. Over three thousand middle school and high school aged girls are assisted through PACE every year. OCBA YLS plans to have a contest costume at the event and will charge a small admission fee to attend (in order to off-set the venue cost). OCBA YLS will also seek sponsors to help offset the venue cost. All funds raised (in excess of the venue cost) will be used to purchase hygiene products for the girls at PACE. The proposed date for the event is March 8, 2022 (International Women's Day).
