Description:**

For the past few years, the YLS has chosen to “adopt” Belle Glade Elementary School, an under-served school in Palm Beach County, at the beginning of the school year at which to hold a Back to School Bash and donate school supplies and snacks to the school’s children. Last year, however, due to COVID, we were unable to hold our Back to School Bash in person, and instead, we donated (1) headphones for all the children to use during their distance learning at home while the school was closed, and (2) custom masks with the school logo for all the teachers and staff that were required to be at the school in person.

This year, once again because of COVID, we are unable to host an in-person Back to School Bash, but we decided to adopt Belle Glade Elementary again because the Western Palm Beach County community is often overlooked for opportunities like this and the COVID cases have been particularly high in that community. This year, the school asked for school spirit t-shirts because the school allows the students to wear t-shirts on Fridays, but a huge number of their students are unable to purchase the spirit shirts.
